This inspection was conducted due to an employer reported referral in which an employee's hand was crushed while unloading Poly Pipe from a semi-trailer.

OPENING CONFERENCE NOTES:

CSHO (b)(7)(C) entered the job site and made contact with the employees on-site. The employees stated they were not the crew involved in the accident but they knew about the accident and knew it happened somewhere close by. The crew did contact the Project Superintendent who agreed to mee with the CSHO at the jobsite office, located down the road. Once at the jobsite office an opening conference was held with the employer. The nature, scope, and purpose of the inspection were explained and additional info. (Fed ID number, OSHA Logs, S&H Programs, etc.) were requested at this time. Other appropriate opening conference items were discussed as well.

Following the opening conference the Project Superintendent explained that he had assigned an operator and two laborers to unload a trailer full of Poly Pipe and place it adjacent to the road so it could it would be ready to be buried when the time came. The operator was picking the pip of the trailer with an excavator and a nylon sling and the two laborers were on the ground directing the operator and getting the pipe placed in the proper area. At the time of the accident the injured employee had his hand on the pipe being lowered and was trying to guide it up against the pipe they had just set on the ground when his hand was crushed between the two pipes.

Poly Pipe Dim. - 50' Long, 3' Dia. & Approx. 1600lbs.

The Superintendent explained that after the accident they had a stand down to discuss the importance of standing in an area to ensure the operator can see you, the possible use of taglines while moving the pipe and the importance of good communication between the crew. The CSHO then asked about interviewing the employees involved and the Superintendent stated the injured employee was out due to his injury and the operator was terminated following the accident (Superintendent did provide phone numbers for both employee) the Superintendent did setup a meeting with the uninjured laborer who the CSHO interviewed after leaving the jobsite office. Before leaving the Superintendent the CSHO explained he would need to talk with the injured employee and the operator before being able to close out the inspection, the Superintendent stated he understood and the CSHO left.

After leaving the jobsite office the CSHO drove to the area of the accident, no work was being performed, and took a few photos of the jobsite and the Poly Pipe.

The CSHO interviewed the uninjured employee the day of the opening, the injured employee and operator were interviewed at different times via phone.

Following the walk around phase of the inspection, a closing conference was held with all employees and the owner on site. The alleged violations were reviewed and the appropriate abatement dates were agreed upon. The company's rights and responsibilities were discussed and an informal conference was encouraged. The CSHOs then exited the site.

Dear Mr. Martin:

An inspection of your workplace at Hwy 59 between East and West Avenue, Waukesha, WI 53186 on 01/13/2022 disclosed the following hazards:

Employees were working at the jobsite were tasked with unloading 50' sections of poly pipe from a trailer onto the shoulder along Hwy 59 between East and West Avenue, Waukesha, WI. At the time of the inspection the employees unloading the poly pipe were not adequately trained on how to pick and place the poly pipe exposing them to struck-by hazards.

Since no OSHA standard applies and it is not considered appropriate at this time to invoke Section 5(a)(1), the general duty clause of the Occupational Safety and Health Act, no citation will be issued for these hazards.

In the interest of workplace safety and health, however, I recommend that you take the following steps voluntarily to eliminate or reduce your employees' exposure t the hazards described above:

- 1. Develop specific procedures for rigging, picking and placing poly pipe from a semi-trailer to the ground. This could include the use of taglines to ensure employees do not have to place themselves or their hands into the hazardous areas.
- 2. Train all affected employees on the above developed procedures to ensure knowledge and reduce the risk of a hazard.
